2010 RURAL HEALTH EXCELLENCE AWARD

For notable contributions to healthcare in rural Colorado

This prestigious award is given annually to honor those who have made a notable contribution to health, healthcare, or a healthcare delivery system in rural Colorado. For 2010, the award will be presented during the 19th Annual Colorado Rural Health Conference this summer. The winner and his or her family will be invited to attend the conference as guests of CRHC. The person submitting the winning nomination can help plan the presentation and personally present the award if s/he wishes to participate.

To be eligible for the award, a candidate must have made a significant contribution to the health, healthcare, or a health-care delivery system in a rural Colorado community, area, or region. Healthcare providers, board members, administrators, volunteers and others are eligible for nomination. Despite their enormous contributions, CRHC Board Members are not eligible for nomination while serving on the Board.

The 2010 deadline for entries is June 4, 2010.
