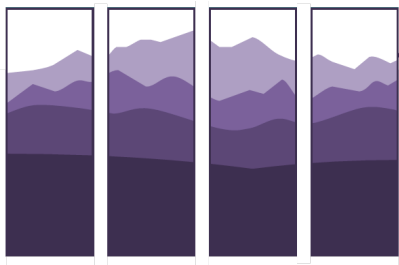


THE FORUM 2010

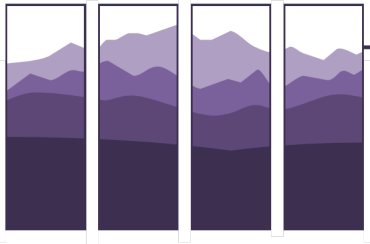
